Human Interest: **FRANK SCARPA** noted that 2020 was the 75th anniversary of the trials of many Nazi war criminals at Nuremberg, Germany. He recalled that his father-in-law, William Coogan, was the allies' chief documentarian responsible for finding and cataloging a vast number of Nazi documents that led to the conviction of participants in many atrocities. **FRANK** read from a document prepared by Mr. Coogan describing his activities as documentarian. He noted that the Nuremberg trials were the first that relied more on incriminating documentation than witnesses.

TODAY'S SPEAKER

BOB RIMMER introduced Michael Mason, Chairman of the Greenwich Board of Estimate and Taxation (BET). Mr. Mason has an extensive resume of service to the town, having served on many town sub-committees since 1992. He has been BET chairman since 2017. Mr. Mason noted that the BET is responsible for the administration of the financial affairs of the town, including the issuance of the annual recommended budget and setting the town tax mill rate. His presentation focused on how the annual budget is prepared and the role of the BET in guiding its development in cooperation with the First Selectman's office and the various town departments. Mr. Mason explained the major line items of the budget, and how they are impacted by contractual obligations (e.g., labor contracts) and other considerations that together lead to the establishment of a mill rate for property taxes. He noted the annual budget must be balanced, and that an initial suggested budget is prepared in October of each year. Following a review by the town departments, the First Selectman prepares a proposed budget. The proposed budget is reviewed in January at a public hearing. The budget is then presented for review by the RTM, which is responsible for approving it by May 15. Mr. Mason noted the town's fiscal position is strong, but Covid-19 has had an impact on this year's budget. That impact has been softened to some degree by grants received by several town departments. He also noted that the town's biggest challenge is managing unfunded liabilities, such as the town's pension fund, which currently stands at about \$200,000,000. Mr.

Mason suggested Greenwich needs to maintain fiscal discipline, while it continues to offer quality amenities and services, so that it remains a desirable community.
