### THIS WEEK'S SPEAKER

The RMA was pleased to have Nelson Tebbe (son of **HORST TEBBE**) making a return as our weekly speaker. Nelson is a professor at Cornell Law School and spoke on *The Roberts Court and the Future of the Free Exercise and Establishment Clauses of the First Amendment*. This proved to be a very enlightening and complex topic. He explained that the constitution's religious reference, as written by James Madison, is fundamentally broken down into two clauses: The Free Exercise Clause and the Establishment Clause. Today, both clauses are being reworked by the Robert's Court. The Free Exercise Clause primarily protects against burdens that pressure someone to act contrary to their religious beliefs and the Establishment Clause addresses the separation of church and state. The Supreme Court's views on religious freedom were somewhat unchallenged and universally accepted up until the 1940's, when the Court seemed to struggle with the meaning of these clauses. Finally, in 1963, with *Sherbert v. Verner*, the Court adopted what is known as the compelling interest test, e.g. if a law substantially burdens the free exercise of religion, it is presumptively unconstitutional. However, in the 1990's many challenges in terms of Civil Rights vs. Religious Freedom became evident, leading to the current situation with conservatives supporting religious freedom and progressives opposing such freedom. *Hobby Lobby*, *Masterpiece Cake Shop*, and *Little Sisters of the Poor* are some of the more notable religious freedom cases of our time. *Fulton vs. City of Philadelphia* is a much-watched case where the Court will revisit the Free Exercise rule. Regarding the Establishment Clause, a major change in the Courts opinion was noted with the decision to allow tax dollars to flow to funding of religious schools under Paycheck Protection Program. This represents a major change in the Court's interpretation regarding the separation of church and state.

Nelson's presentation gave rise to several Q&A contemporary issues pertaining to our religious freedoms and how the US Supreme Court will view them.
