

The talk was Law and Order meets The West Wing.

NFL, the prosecution of drug-dealer Nicky Barnes, and the Whitewater case during the Clinton administration. Who is eligible: Any member of RMA can participate

#### What are the rules:

- 1. Your rhyming 4 or 5 line entry must be on a topic relating to RMA...but be "clean enough to be read aloud in mixed company." ONLY ONE ENTRY PER MEMBER PLEASE.
- 2. Your rhyme must end with the initials RMA. Note: RMA cannot be part of your 4-5 line rhyme.
- 3. How you rhyme your verse is up to you. Note: historically some Burma Shave roadside ads did not rhyme but eventually they all did...so to simplify things....we will have rhymed entries.
- 4. All entries must be submitted in writing (preferably via e-mail) to both PETER UHRY and ARNOLD GORDON by Friday June 9<sup>th</sup>.

- 5. To be eligible for the over the top fabulous low cost prizes (what they are we have no idea yet), you must be present on June 14 to read your entry. Fame and glory will be given to the top three entries. The winning rhymes will be posted in the CBB.
- 6. Like our limerick contest of last year, a panel of inexperienced amateurs will be named to select their top three entries. Then the members will be asked to vote on the three to declare the 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> place horses (er, rhymers).
