It is now named after him. **DOUG** was a member from October 1990; he died a year

ago January at the age of 91, having been a member for some 30 years. There is a picture of him in the article wearing his RMA hat. His wife and son are still active at the Exchange, which reopened on July 16<sup>th</sup> after having been closed since the beginning of the pandemic in March 2020. Visiting: MICHAEL AMBROSINO reported that no news is good news.



**PETER BERG** introduced today's speaker, Connecticut Attorney General Willian Tong who spoke on "The Pandemic and the Law." A.G. Tong started off by reviewing the history of the pandemic in Connecticut from the early days when the state was very hard hit, a consequence of being located between New York City and Boston, both hard hit cities and with open borders (at least in the beginning), to today, when 98% of citizens over 65 are vaccinated. The Delta variant now threatens to undo some of the gains made to date.

All the actions by the State to keep us safe emanate from the Governor's power to act in an emergency. These powers, Tong explained, are by statute, granted by the legislature which reserves the right to review and potentially overrule the Governor's actions. The "state of emergency" and the Governor's ability to act, are only good for six months and must be renewed. There have been renewals since the first proclamation in March 2020. He explained his role in governing during the pandemic included advising the Governor, investigating and remediating price gouging and the return of deposits for events which did not happen, and fighting vaccination disinformation.

During his talk, before explaining a point of law, he would comment, "now for some Law School 101." For we non-lawyers, most of the talk was an easy intro to Law School 101.

During the spirited Q & A after the talk, A.G. Tong was asked to comment on the settlement made by big pharma and the several states who sued them for overselling opioids. He commented that he was unhappy with the cash settlements which were not big enough and did not hurt the industry enough. He felt that the Sackler Family got a free pass despite the fact that their company Purdue Pharma was forced into bankruptcy.

Another high-quality talk from our prolific Program Committee.
