## **TODAY'S SPEAKER**

**Christopher Bruhl**, President and Chief Executive Officer of the Business Council of Fairfield County spoke on "Connecticut and Fairfield County Business Trends." He presented an incisive look at the present day labor pool, transportation facilities, educational institutions, and demographics in this area.
